By providing the Publication with text, digital and/or graphic material (hereinafter: "materials"), the Contributor permits the Newspaper to use the material as it sees fit and in accordance with the following terms:

1. The Contributor retains copyright ownership of the material they produced, as well as all print and electronic rights under the conditions of this agreement.
2. The Publication may publish the Contributor's material in print as well as on its website.
3. The Contributor grants the Publication a non-exclusive license to reproduce materials in print and/or electronically as part of its archives.
4. Remuneration will revert to the Contributor whenever republication revenue can be deemed as generated from a specific article.

Should the Contributor be unreachable, the money will go to ventures that benefit all The Link contributors and members, projects or causes that the Publication deems to be beneficial to the journalistic community.

5. At all times, proper creator attribution will be maintained. The Contributor may not publish their material (in part or in whole) elsewhere on the same day as it is printed in the Publication.

6. Regarding clause five above, a series of shots from the same photo assignment constitute the “material,” and, therefore, once shots from a given assignment are used, the provisions apply to all the shots from the assignment, used and unused alike.

7. The Contributor declares and promises that all materials that they supply to the Publication are original unless the parties agree otherwise and that publication of the materials by the Publication does not violate any third party's copyright interests. The Contributor shall be liable – towards aggrieved third parties and the Publication – for any damages that result from violation of this declaration and promise.

8. The Publication may edit all material for publication, in accordance with the Contributor's moral rights, as defined by the Canadian Copyright Act.

9. The contributor grants Canadian University Press members the right to reproduce materials in print and/or electronically, with full attribution.

10. Either parties may terminate this agreement at any time, by notice in writing. Termination will not affect any rights granted hereunder over material submitted prior to said termination. That termination is only effective two weeks after written notice.
